ONE OF THE ENDURING TENSIONS IN LOCAL ECONOMIC DEVELOPMENT IS BALANCING ECONOMIC GROWTH WITH SOCIAL EQUITY AND ENVIRONMENTAL SUSTAINABILITY. AGGRESSIVE GROWTH STRATEGIES MAY LEAD TO GENTRIFICATION, DISPLACEMENT, OR ENVIRONMENTAL DEGRADATION IF NOT CAREFULLY MANAGED. These and other considerations are explored in more detail by authors in this volume. Local policymakers and practitioners will be continually pressured to provide more documentation of outcomes and readers will gain considerable insights into alternative approaches that can be included in projects but can also see the common elements needed to create a solid measurement system.
