Salvatore's dream to study medicine and help people propelled him to carry on and continue his education, eventually being educated and living on three different continents, each with a new language to learn and master. Despite his meager beginnings which provided no social and little educational opportunity and despite the many years and setbacks it took him to accomplish this, his goal was ultimately accomplished because of his sheer determination.
