The independent variables were Constraint-Induced Language Therapy and semantic category of training stimuli. The dependent variables were the accuracy of sentence production and word retrieval for semantic category words and standardized test scores. Overall, the participants demonstrated positive changes in sentence production and word retrieval only following the second treatment phase. No consistent pattern of generalization was evident within and across semantic categories. The improvement following CILT appeared to be due to cumulative treatment intensity that affected both categories.
