FOR INSTANCE, THE PREFRONTAL CORTEX IS HIGHLIGHTED FOR ITS INVOLVEMENT IN EXECUTIVE FUNCTIONS LIKE PLANNING, DECISION-MAKING, AND SOCIAL BEHAVIOR. DAMAGE TO THIS AREA OFTEN RESULTS IN PROFOUND CHANGES IN PERSONALITY AND IMPULSE CONTROL, AS DEMONSTRATED BY FAMOUS HISTORICAL CASES.

SIMILARLY, THE HIPPOCAMPUS IS EMPHASIZED FOR ITS CRUCIAL ROLE IN MEMORY FORMATION. KOLB AND WHISHAW DETAIL HOW DAMAGE TO THIS STRUCTURE CAN CAUSE ANTEROGRADE AMNESIA, SHEDDING LIGHT ON THE NEURAL UNDERPINNINGS OF LEARNING AND MEMORY.

The cognitive level refers to the underlying cognitive processes that are reflected in the test scores.
