The gold standard allowed the U.S. to secure vast amounts of foreign capital on good terms to build railroads and develop industry, but at the cost of deflation. The free coinage of silver would raise prices, particularly for cotton and wheat, whose cultivators carried heavy debts and were hard-pressed. The struggle would define the United States.
