THE FOUNDATIONS OF AMERICAN HIGHER EDUCATION

THESE EARLY SCHOOLS WERE DEEPLY INTERTWINED WITH THE PURITAN MISSION, EMPHASIZING CLASSICAL EDUCATION AND MORAL INSTRUCTION.

COLONIAL COLLEGES AND THEIR RELIGIOUS ROOTS

IN THE 17TH AND 18TH CENTURIES, MOST COLLEGES IN AMERICA WERE EXTENSIONS OF RELIGIOUS DENOMINATIONS. INSTITUTIONS LIKE YALE, WILLIAM & MARY, AND PRINCETON ALL BEGAN WITH A FOCUS ON THEOLOGY AND CLASSICAL STUDIES. THE CURRICULUM WAS CENTERED ON LATIN, GREEK, AND BIBLICAL STUDIES, REFLECTING THE BELIEF THAT EDUCATION WAS A MEANS TO CREATE MORAL AND LEARNED CITIZENS.

HOWEVER, AS THELIN HIGHLIGHTS, THIS RELIGIOUS FOUNDATION DID NOT REMAIN STATIC. THE ENLIGHTENMENT AND THE RISE OF SECULAR IDEAS GRADUALLY INFLUENCED THE MISSION AND CURRICULUM OF THESE INSTITUTIONS, SETTING THE STAGE FOR A BROADER EDUCATIONAL SCOPE.

THE EXPANSION AND DIVERSIFICATION OF HIGHER EDUCATION

MOVING INTO THE 19TH CENTURY, THELIN'S HISTORY REVEALS DRAMATIC GROWTH AND DIVERSIFICATION IN AMERICAN HIGHER EDUCATION. THE RISE OF THE NATION-STATE, THE INDUSTRIAL REVOLUTION, AND WESTWARD EXPANSION ALL CONTRIBUTED TO A DEMAND FOR NEW KINDS OF KNOWLEDGE AND SKILLS.

THE MORRILL LAND-GRANT ACTS AND PRACTICAL EDUCATION

ONE OF THE MOST PIVOTAL MOMENTS THELIN EMPHASIZES IS THE PASSAGE OF THE MORRILL LAND-GRANT ACTS IN 1862 AND 1890. THESE LAWS GRANTED FEDERAL LAND TO STATES TO ESTABLISH COLLEGES FOCUSED ON AGRICULTURE, ENGINEERING, AND THE MECHANICAL ARTS. THIS MARKED A SHIFT FROM PURELY CLASSICAL EDUCATION TO MORE PRACTICAL, APPLIED SCIENCES AIMED AT SERVING SOCIETAL NEEDS.

LAND-GRANT UNIVERSITIES LIKE MICHIGAN STATE AND TEXAS A&M BECAME LEADERS IN THIS MOVEMENT, PROVIDING ACCESSIBLE EDUCATION TO BROADER POPULATIONS AND FOSTERING RESEARCH THAT SUPPORTED INDUSTRIAL AND AGRICULTURAL

DEVELOPMENT.

THE RISE OF THE RESEARCH UNIVERSITY

THE LATE 19TH AND EARLY 20TH CENTURIES ALSO SAW THE EMERGENCE OF THE MODERN RESEARCH UNIVERSITY IN AMERICA. INSPIRED BY THE GERMAN MODEL OF HIGHER EDUCATION, INSTITUTIONS SUCH AS JOHNS HOPKINS UNIVERSITY PRIORITIZED ORIGINAL RESEARCH ALONGSIDE TEACHING.

THELIN NOTES THAT THIS SHIFT SIGNIFICANTLY CHANGED FACULTY ROLES AND INSTITUTIONAL PRIORITIES. UNIVERSITIES BEGAN TO EMPHASIZE GRADUATE EDUCATION AND THE CREATION OF NEW KNOWLEDGE, LAYING THE GROUNDWORK FOR AMERICA'S LEADERSHIP IN GLOBAL SCIENCE AND INNOVATION.

SOCIAL MOVEMENTS AND ACCESS TO HIGHER EDUCATION

INSTITUTIONS LIKE VASSAR, SMITH, AND WELLESLEY PROVIDED OPPORTUNITIES FOR WOMEN TO PURSUE ADVANCED LEARNING. THELIN DISCUSSES HOW THIS EXPANSION WAS PART OF BROADER SOCIAL REFORM MOVEMENTS ADVOCATING FOR WOMEN'S RIGHTS AND EDUCATION.

DESPITE THESE ADVANCES, GENDER DISPARITIES PERSISTED WELL INTO THE 20TH CENTURY, AND THELIN'S WORK SHEDS LIGHT ON THE CONTINUED EFFORTS TO ACHIEVE GENDER EQUITY IN ACADEMIA.

RACIAL INTEGRATION AND THE CIVIL RIGHTS ERA

RACIAL SEGREGATION WAS DEEPLY ENTRENCHED IN AMERICAN HIGHER EDUCATION FOR MUCH OF ITS HISTORY. THELIN'S HISTORY DETAILS THE CREATION OF HISTORICALLY BLACK COLLEGES AND UNIVERSITIES (HBCUs) AS VITAL INSTITUTIONS FOR AFRICAN AMERICANS DENIED ACCESS TO PREDOMINANTLY WHITE COLLEGES.

THE CIVIL RIGHTS MOVEMENT OF THE 1950S AND 1960S CATALYZED SIGNIFICANT LEGAL AND CULTURAL CHANGES, LEADING TO DESEGREGATION EFFORTS AND AFFIRMATIVE ACTION POLICIES. EXPANSION AND DIVERSIFICATION IN THE 20TH CENTURY

THE 20TH CENTURY MARKED A PERIOD OF RAPID EXPANSION FOR AMERICAN HIGHER EDUCATION, A PHENOMENON THELIN THOROUGHLY DOCUMENTS. CHALLENGES AND CRITIQUES IN CONTEMPORARY HIGHER EDUCATION
