WHAT IS THE FINRA SERIES 79 EXAM?

THE FINRA SERIES 79, OFFICIALLY KNOWN AS THE INVESTMENT BANKING REPRESENTATIVE QUALIFICATION EXAMINATION, IS DESIGNED TO ASSESS THE COMPETENCY OF CANDIDATES INVOLVED IN INVESTMENT BANKING ACTIVITIES. UNLIKE MORE GENERAL SECURITIES EXAMS, SUCH AS THE SERIES 7, THE SERIES 79 FOCUSES SPECIFICALLY ON THE SKILLS NEEDED FOR ADVISING ON OR FACILITATING DEBT OR EQUITY OFFERINGS, MERGERS AND ACQUISITIONS, TENDER OFFERS, AND OTHER INVESTMENT BANKING TRANSACTIONS.

THE EXAM IS ADMINISTERED BY THE FINANCIAL INDUSTRY REGULATORY AUTHORITY (FINRA), THE SELF-REGULATORY ORGANIZATION OVERSEEING BROKER-DEALERS AND REGISTERED SECURITIES REPRESENTATIVES IN THE UNITED STATES. PASSING THE SERIES 79 IS TYPICALLY A PREREQUISITE FOR PROFESSIONALS WORKING FOR BROKER-DEALERS WHO ENGAGE IN INVESTMENT BANKING SERVICES.

WHO NEEDS TO TAKE THE SERIES 79?

NOT EVERY SECURITIES PROFESSIONAL NEEDS THE SERIES 79. IT'S TAILORED SPECIFICALLY FOR THOSE WHOSE JOB FUNCTIONS INCLUDE:

- ADVISING ON OR FACILITATING CORPORATE MERGERS AND ACQUISITIONS (M&A)
- UNDERWRITING OR SELLING CORPORATE SECURITIES
- CONDUCTING TENDER OFFERS OR FINANCIAL RESTRUCTURING
- PROVIDING CORPORATE FINANCE ADVICE TO CLIENTS

IF YOUR ROLE INVOLVES THESE ACTIVITIES, ESPECIALLY IN AN INVESTMENT BANKING DIVISION, THE SERIES 79 EXAM IS LIKELY MANDATORY.

EXAM STRUCTURE AND CONTENT OVERVIEW

1. **COLLECTION, ANALYSIS, AND EVALUATION OF DATA (30%)**

THIS SECTION TESTS YOUR ABILITY TO ANALYZE FINANCIAL STATEMENTS, INTERPRET MARKET DATA, AND REVIEW REGULATORY

FILINGS TO SUPPORT INVESTMENT BANKING TRANSACTIONS.

2. ****UNDERWRITING/NEW FINANCING TRANSACTIONS (27%)****

QUESTIONS HERE FOCUS ON THE MECHANICS OF UNDERWRITING SECURITIES OFFERINGS, UNDERSTANDING DIFFERENT TYPES OF FINANCING, AND RELATED REGULATORY REQUIREMENTS.

3. ****MERGERS AND ACQUISITIONS, TENDER OFFERS, AND FINANCIAL RESTRUCTURING TRANSACTIONS (40%)****

THE LARGEST PORTION, THIS TESTS YOUR KNOWLEDGE OF M&A PROCESSES, TENDER OFFERS, FAIRNESS OPINIONS, AND RESTRUCTURING STRATEGIES.

4. ****GENERAL KNOWLEDGE (3%)****

THIS SMALLER SECTION COVERS ETHICS, PROFESSIONAL CONDUCT, AND GENERAL REGULATORY OBLIGATIONS.

KEY STUDY TIPS FOR THE FINRA SERIES 79 EXAM

USE QUALITY STUDY MATERIALS

THE ROLE OF THE SERIES 79 IN LICENSING

ONE IMPORTANT ASPECT TO NOTE IS THAT THE SERIES 79 EXAM MUST BE TAKEN IN CONJUNCTION WITH THE SECURITIES INDUSTRY ESSENTIALS (SIE) EXAM. THE SIE COVERS FUNDAMENTAL SECURITIES INDUSTRY KNOWLEDGE AND IS A PREREQUISITE FOR MOST FINRA REPRESENTATIVE-LEVEL EXAMS, INCLUDING THE SERIES 79.

ADDITIONALLY, SOME FIRMS REQUIRE CANDIDATES TO ALSO HOLD OTHER LICENSES, SUCH AS THE SERIES 63 OR SERIES 66, DEPENDING ON THE STATE AND THE SPECIFIC ROLES THE REPRESENTATIVE WILL UNDERTAKE.

COMMON CHALLENGES AND HOW TO OVERCOME THEM

TEST ANXIETY AND TIME PRESSURE

THE PRESSURE OF A TIMED EXAM CAN AFFECT PERFORMANCE. INCORPORATING RELAXATION TECHNIQUES, ENSURING ADEQUATE REST BEFORE THE TEST DAY, AND SIMULATING EXAM CONDITIONS DURING PRACTICE CAN REDUCE ANXIETY.

KEEPING UP WITH REGULATORY CHANGES

FINRA PERIODICALLY UPDATES EXAM CONTENT TO REFLECT NEW RULES OR MARKET DEVELOPMENTS. STAYING INFORMED THROUGH OFFICIAL FINRA BULLETINS OR TRUSTED INDUSTRY RESOURCES ENSURES YOU'RE STUDYING THE MOST CURRENT MATERIAL.

UNDERSTANDING THE FINRA SERIES 79 EXAM

THE SERIES 79 EXAM, OFFICIALLY KNOWN AS THE INVESTMENT BANKING REPRESENTATIVE QUALIFICATION EXAMINATION, IS DESIGNED TO EVALUATE THE PROFICIENCY OF REPRESENTATIVES IN EXECUTING INVESTMENT BANKING FUNCTIONS. UNLIKE BROADER SECURITIES EXAMS THAT COVER A WIDE ARRAY OF FINANCIAL PRODUCTS, SERIES 79 FOCUSES SPECIFICALLY ON THE COMPLEX PROCESSES AND REGULATORY FRAMEWORKS THAT GOVERN INVESTMENT BANKING TRANSACTIONS.

EXAM STRUCTURE AND CONTENT BREAKDOWN

THE SERIES 79 EXAM CONSISTS OF 75 MULTIPLE-CHOICE QUESTIONS, WITH CANDIDATES ALLOTTED 2 HOURS AND 30 MINUTES TO COMPLETE IT. TO PASS, CANDIDATES MUST CORRECTLY ANSWER AT LEAST 73% OF THE QUESTIONS, EQUATING TO A MINIMUM OF 55 CORRECT RESPONSES. THE EXAM ENCOMPASSES SEVERAL CORE AREAS INCLUDING:

- **UNDERWRITING/NEW FINANCING TRANSACTIONS:** PROCEDURES FOR PUBLIC OFFERINGS, PRIVATE PLACEMENTS, AND DEBT FINANCING.
- **SOLICITATION, PURCHASE, AND SALE OF SECURITIES:** COMPREHENSION OF REGULATORY REQUIREMENTS, DUE DILIGENCE, AND CLIENT COMMUNICATION.
- **MERGERS AND ACQUISITIONS (M&A):** STRUCTURING, NEGOTIATION, AND EXECUTION OF M&A DEALS.

THE EMPHASIS ON THESE TOPICS ALIGNS WITH THE REAL-WORLD RESPONSIBILITIES OF INVESTMENT BANKERS, ENSURING THAT LICENSED INDIVIDUALS POSSESS THE TECHNICAL KNOWLEDGE AND REGULATORY AWARENESS NECESSARY TO OPERATE EFFECTIVELY.

ELIGIBILITY AND PREREQUISITES

UNLIKE SOME OTHER FINRA EXAMS, THE SERIES 79 DOES NOT HAVE EXPLICIT PREREQUISITES, MEANING CANDIDATES CAN SIT FOR IT WITHOUT HAVING PASSED OTHER QUALIFICATION EXAMS. HOWEVER, IT IS TYPICALLY TAKEN BY PROFESSIONALS ALREADY WORKING WITHIN A BROKER-DEALER FIRM OR THOSE PURSUING A CAREER IN INVESTMENT BANKING. FIRMS OFTEN REQUIRE CANDIDATES TO COMPLETE THE SERIES 79 EXAM ALONGSIDE THE GENERAL SECURITIES REGISTRATION EXAM, SERIES 7, TO BROADEN THEIR LICENSING CAPABILITIES.

SIGNIFICANCE OF THE SERIES 79 LICENSE IN THE FINANCIAL INDUSTRY

HOLDING THE SERIES 79 LICENSE SIGNALS TO EMPLOYERS AND CLIENTS THAT AN INDIVIDUAL IS QUALIFIED TO PARTICIPATE IN THE SOPHISTICATED PROCESSES INHERENT IN INVESTMENT BANKING. IT IS A SPECIALIZED CREDENTIAL THAT DIFFERENTIATES INVESTMENT BANKERS FROM GENERAL SECURITIES REPRESENTATIVES, WHO MAY FOCUS ON RETAIL SALES OR BROADER FINANCIAL SERVICES.

CAREER IMPLICATIONS AND INDUSTRY DEMAND

INVESTMENT BANKING REMAINS A HIGHLY COMPETITIVE FIELD, AND POSSESSING THE SERIES 79 CERTIFICATION CAN ENHANCE PROFESSIONAL CREDIBILITY AND MARKETABILITY. FIRMS ENGAGED IN UNDERWRITING AND ADVISING ON SECURITIES TRANSACTIONS

RELY ON LICENSED REPRESENTATIVES TO COMPLY WITH REGULATORY MANDATES AND SAFEGUARD CLIENT INTERESTS. CONSEQUENTLY, MANY JOB DESCRIPTIONS FOR INVESTMENT BANKING ANALYSTS, ASSOCIATES, AND REPRESENTATIVES EXPLICITLY LIST THE SERIES 79 EXAM AS A REQUIREMENT OR PREFERRED QUALIFICATION.

ADDITIONALLY, THE REGULATORY LANDSCAPE SURROUNDING SECURITIES TRANSACTIONS CONTINUES TO EVOLVE, REINFORCING THE NEED FOR QUALIFIED PROFESSIONALS WHO STAY ABREAST OF COMPLIANCE STANDARDS. THE SERIES 79 EXAM ENSURES THAT INDIVIDUALS POSSESS UP-TO-DATE KNOWLEDGE OF FEDERAL SECURITIES LAWS AND FINRA RULES RELEVANT TO INVESTMENT BANKING ACTIVITIES.

COMPARISON WITH OTHER FINRA EXAMS

- **SERIES 63 (UNIFORM SECURITIES AGENT STATE LAW EXAMINATION):** ADDRESSES STATE SECURITIES REGULATIONS AND IS TYPICALLY REQUIRED ALONGSIDE SERIES 79 FOR STATE REGISTRATION.
- **SERIES 24 (GENERAL SECURITIES PRINCIPAL):** QUALIFIES INDIVIDUALS TO SUPERVISE AND MANAGE BROKER-DEALER ACTIVITIES, INCLUDING THOSE RELATED TO INVESTMENT BANKING.

CANDIDATES TARGETING A CAREER IN INVESTMENT BANKING OFTEN PURSUE THE SERIES 79 EXAM SPECIFICALLY BECAUSE IT CONCENTRATES ON THEIR CORE FUNCTIONAL AREA WITHOUT THE BROADER SALES-ORIENTED CONTENT OF THE SERIES 7.

PREPARATION STRATEGIES FOR THE SERIES 79 EXAM
