In 1820 she moved to Philadelphia Pennsylvania and joined the Quakers. On Sundays, at age 12 Sarah would teach Bible classes to the slaves. Sarah's parents warned her to stop her teachings because it was against the law to teach slaves to read in South Carolina since 1740. In secret Sarah continued to show her personal slave Hetty, when her father found it out he threatened to have the slave girl whip. Sarah was very unhappy but for the sake of Hetty stopped teaching her. The Pioneers continued to encourage the slaves to accept the Christian faith, and get baptized, but they refused to show them to read. Sarah felt the whites did not see them as real brothers and sisters in the Lord, otherwise they would be taught to read the bible. Her younger sister followed her, and together they started working with the abolitionist movement. Together they traveled to speaking events around the state. She died on December 23, 1873.
