However, defection during the peace process served not only to optimize the defector's utilities, but eventually proved beneficial for the parties left behind. Kober determines that the peace process, mainly due to superpower involvement, transformed the scenario from a zero-sum to a non-zero-sum game, by rewarding the parties for signing treaties with Israel. Also, the first defectors, such as Egypt, established pay-off precedents, creating the foundation for future negotiations between the Arab players and Israel.
