PODIATRY SCOPE OF PRACTICE BY STATE: NAVIGATING THE DIFFERENCES ACROSS THE U.S.

PODIATRY SCOPE OF PRACTICE BY STATE IS A TOPIC THAT OFTEN SURPRISES MANY HEALTHCARE PROFESSIONALS AND PATIENTS ALIKE. WHILE PODIATRISTS ARE RECOGNIZED AS SPECIALISTS IN FOOT AND ANKLE HEALTH NATIONWIDE, THE EXACT PARAMETERS OF WHAT THEY CAN DO LEGALLY VARY SIGNIFICANTLY DEPENDING ON WHERE THEY PRACTICE. UNDERSTANDING THESE DIFFERENCES IS CRUCIAL NOT ONLY FOR PODIATRISTS PLANNING TO RELOCATE OR EXPAND THEIR PRACTICE BUT ALSO FOR PATIENTS SEEKING CARE AND INSURERS DETERMINING COVERAGE POLICIES. SO, WHAT EXACTLY SHAPES THESE VARIATIONS, AND HOW DO THEY IMPACT THE EVERYDAY PRACTICE OF PODIATRY? LET'S DIVE DEEPER INTO THE LANDSCAPE OF PODIATRY SCOPE OF PRACTICE BY STATE.

UNDERSTANDING THE FUNDAMENTALS OF PODIATRY SCOPE OF PRACTICE

BEFORE EXPLORING STATE-SPECIFIC NUANCES, IT'S IMPORTANT TO GRASP WHAT "SCOPE OF PRACTICE" MEANS IN THE CONTEXT OF PODIATRY. ESSENTIALLY, IT REFERS TO THE RANGE OF PROCEDURES, TREATMENTS, AND INTERVENTIONS THAT A LICENSED PODIATRIST IS AUTHORIZED TO PERFORM. THIS SCOPE IS DEFINED BY STATE LAW AND REGULATORY BOARDS, WHICH OUTLINE WHAT PODIATRISTS CAN AND CANNOT DO WITHIN THEIR JURISDICTION.

IN GENERAL, PODIATRISTS FOCUS ON DIAGNOSING AND TREATING CONDITIONS AFFECTING THE FOOT, ANKLE, AND LOWER LEG. THIS INCLUDES MANAGING INJURIES, DEFORMITIES, INFECTIONS, CIRCULATORY ISSUES, AND EVEN PERFORMING SURGERY WHEN NECESSARY. HOWEVER, THE DEPTH AND BREADTH OF THESE CAPABILITIES DIFFER DEPENDING ON THE STATE, OFTEN INFLUENCED BY LOCAL LEGISLATION, HISTORICAL FACTORS, AND LOBBYING EFFORTS BY VARIOUS MEDICAL GROUPS.

WHY DOES THE PODIATRY SCOPE OF PRACTICE VARY SO MUCH?

SEVERAL FACTORS CONTRIBUTE TO THE DIVERSE PODIATRY SCOPE OF PRACTICE BY STATE:

- **STATE MEDICAL BOARDS AND REGULATIONS:** EACH STATE HAS ITS OWN MEDICAL BOARD OR PODIATRY BOARD THAT REGULATES LICENSES AND DEFINES PRACTICE BOUNDARIES.
- **LEGISLATIVE ENVIRONMENT:** LAWS PASSED AT THE STATE LEVEL CAN EITHER EXPAND OR RESTRICT PODIATRIC PRACTICE, SOMETIMES IN RESPONSE TO LOBBYING BY OTHER HEALTHCARE PROFESSIONALS.
- **HISTORICAL AND CULTURAL FACTORS:** STATES WITH A LONG HISTORY OF PODIATRIC CARE OFTEN HAVE BROADER SCOPES, WHILE OTHERS MAY LIMIT PODIATRISTS TO MORE BASIC CARE.
- **EDUCATIONAL STANDARDS:** DIFFERENCES IN PODIATRIC SCHOOL ACCREDITATIONS AND TRAINING PROGRAMS CAN ALSO PLAY A ROLE.
- **HEALTHCARE MARKET NEEDS:** IN RURAL OR UNDERSERVED AREAS, SCOPES MAY EXPAND TO COVER MORE GENERAL FOOT AND ANKLE CARE DUE TO FEWER SPECIALISTS.

KEY VARIATIONS IN PODIATRY PRACTICE ACROSS STATES

WHEN LOOKING AT PODIATRY SCOPE OF PRACTICE BY STATE, SEVERAL CORE AREAS SHOW NOTICEABLE DIFFERENCES:

1. SURGICAL PRIVILEGES

ONE OF THE MOST SIGNIFICANT DISTINCTIONS IS WHETHER PODIATRISTS ARE ALLOWED TO PERFORM SURGERY AND, IF SO, WHICH TYPES. IN MANY STATES, PODIATRISTS PERFORM OUTPATIENT FOOT AND ANKLE SURGERIES, INCLUDING BUNION CORRECTIONS, FRACTURE REPAIRS, AND TENDON PROCEDURES. HOWEVER, SOME STATES RESTRICT PODIATRISTS FROM CERTAIN SURGICAL INTERVENTIONS OR REQUIRE SPECIFIC CERTIFICATIONS.

FOR EXAMPLE, STATES LIKE CALIFORNIA AND TEXAS OFFER BROAD SURGICAL PRIVILEGES TO LICENSED PODIATRISTS, ALLOWING THEM TO PERFORM BOTH SOFT TISSUE AND OSSEOUS SURGERY. MEANWHILE, A FEW STATES MAY LIMIT PODIATRIC SURGEONS TO ONLY SOFT TISSUE PROCEDURES OR REQUIRE COLLABORATION WITH ORTHOPEDIC SURGEONS FOR MORE COMPLEX OPERATIONS.

2. PRESCRIPTION AUTHORITY

ANOTHER VARIATION LIES IN THE ABILITY TO PRESCRIBE MEDICATIONS. ALMOST ALL STATES GRANT PODIATRISTS THE AUTHORITY TO PRESCRIBE DRUGS RELATED TO FOOT AND ANKLE CARE, INCLUDING ANTIBIOTICS, ANTI-INFLAMMATORY MEDICATIONS, AND PAIN RELIEVERS. YET, THE RANGE CAN DIFFER — SOME STATES ALLOW PODIATRISTS TO PRESCRIBE CONTROLLED SUBSTANCES, WHILE OTHERS IMPOSE MORE RESTRICTIONS.

UNDERSTANDING THESE BOUNDARIES IS ESSENTIAL SINCE MEDICATION MANAGEMENT IS A CRITICAL COMPONENT OF TREATING INFECTIONS, DIABETIC FOOT ULCERS, AND OTHER PODIATRIC CONDITIONS.

3. DIAGNOSTIC IMAGING AND TESTING

ACCESS TO DIAGNOSTIC TOOLS LIKE X-RAYS, MRI, AND LAB TESTS IS VITAL IN PODIATRY. MOST STATES PERMIT PODIATRISTS TO ORDER AND INTERPRET DIAGNOSTIC IMAGING NECESSARY FOR THEIR PRACTICE. HOWEVER, THE EXTENT TO WHICH THEY CAN DIRECTLY PERFORM THESE TESTS OR USE ADVANCED IMAGING VARIES. SOME STATES REQUIRE PODIATRISTS TO PARTNER WITH RADIOLOGISTS OR OTHER SPECIALISTS FOR CERTAIN DIAGNOSTICS.

4. ANESTHESIA ADMINISTRATION

ADMINISTERING ANESTHESIA, PARTICULARLY FOR SURGICAL PROCEDURES, IS ANOTHER AREA WHERE SCOPE VARIES. IN MANY STATES, PODIATRISTS CAN ADMINISTER LOCAL AND REGIONAL ANESTHESIA, BUT GENERAL ANESTHESIA OR SEDATION MAY BE RESTRICTED TO THOSE WITH ADDITIONAL CERTIFICATIONS OR SUPERVISED SETTINGS.

STATE EXAMPLES: SPOTLIGHT ON SPECIFIC JURISDICTIONS

TO GIVE A CLEARER PICTURE OF HOW PODIATRY SCOPE OF PRACTICE BY STATE PLAYS OUT IN REALITY, LET'S LOOK AT A FEW EXAMPLES:

CALIFORNIA

CALIFORNIA IS KNOWN FOR HAVING ONE OF THE BROADEST PODIATRY SCOPES. LICENSED DOCTORS OF PODIATRIC MEDICINE (DPMs) HERE CAN PERFORM EXTENSIVE FOOT AND ANKLE SURGERIES, PRESCRIBE A WIDE RANGE OF MEDICATIONS INCLUDING CONTROLLED SUBSTANCES, AND ORDER DIAGNOSTIC IMAGING INDEPENDENTLY. THE STATE ALSO ALLOWS PODIATRISTS TO ADMINISTER VARIOUS FORMS OF ANESTHESIA DURING PROCEDURES.

NEW YORK

NEW YORK OFFERS A ROBUST SCOPE BUT WITH SOME NUANCES. PODIATRISTS CAN PERFORM SURGERY AND PRESCRIBE MEDICATIONS, BUT THERE ARE TIGHTER REGULATIONS AROUND ANESTHESIA ADMINISTRATION. ADDITIONALLY, CERTAIN PROCEDURES MAY REQUIRE HOSPITAL PRIVILEGES OR COLLABORATION WITH OTHER SPECIALISTS.

TEXAS

TEXAS GRANTS PODIATRISTS COMPREHENSIVE SURGICAL PRIVILEGES AND PRESCRIPTION AUTHORITY SIMILAR TO CALIFORNIA. THE STATE HAS ACTIVELY WORKED TO EXPAND PODIATRIC PRACTICE THROUGH LEGISLATION, RECOGNIZING THE IMPORTANCE OF FOOT AND ANKLE SPECIALISTS IN ITS HEALTHCARE SYSTEM.

FLORIDA

FLORIDA'S PODIATRY SCOPE IS FAIRLY BROAD BUT INCLUDES SPECIFIC REGULATORY REQUIREMENTS FOR SURGICAL PROCEDURES AND MEDICATION PRESCRIPTIONS. PODIATRISTS MUST ADHERE TO CONTINUING EDUCATION AND CERTIFICATION STANDARDS TO MAINTAIN THESE PRIVILEGES.

TIPS FOR PODIATRISTS NAVIGATING SCOPE OF PRACTICE DIFFERENCES

IF YOU'RE A PODIATRIST PRACTICING IN MULTIPLE STATES OR CONSIDERING RELOCATION, UNDERSTANDING THESE SCOPE VARIATIONS IS KEY TO MAINTAINING COMPLIANCE AND PROVIDING QUALITY CARE. HERE ARE SOME TIPS:

- **REVIEW STATE REGULATIONS ANNUALLY:** LAWS CAN CHANGE, SO STAYING UPDATED WITH STATE MEDICAL AND PODIATRY BOARDS IS ESSENTIAL.
- **MAINTAIN CONTINUING EDUCATION:** MANY STATES REQUIRE ONGOING EDUCATION TO PRESERVE SURGICAL AND PRESCRIPTION PRIVILEGES.
- **UNDERSTAND COLLABORATIVE REQUIREMENTS:** SOME STATES REQUIRE PODIATRISTS TO WORK WITH OTHER PHYSICIANS FOR SPECIFIC PROCEDURES OR PRESCRIPTIONS.
- **CONSULT LEGAL COUNSEL OR PROFESSIONAL ASSOCIATIONS:** WHEN IN DOUBT, REACH OUT TO LEGAL EXPERTS OR NATIONAL PODIATRY ORGANIZATIONS FOR GUIDANCE.
- **EDUCATE PATIENTS ABOUT YOUR SCOPE:** CLEAR COMMUNICATION HELPS MANAGE EXPECTATIONS, ESPECIALLY WHEN PATIENTS MOVE FROM ONE STATE TO ANOTHER.

THE IMPACT OF SCOPE OF PRACTICE ON PATIENT CARE

VARIATIONS IN PODIATRY SCOPE OF PRACTICE BY STATE DON'T JUST INFLUENCE THE PODIATRISTS THEMSELVES—THEY DIRECTLY AFFECT PATIENT EXPERIENCES AND OUTCOMES. IN STATES WITH EXPANDED SCOPES, PATIENTS OFTEN HAVE BETTER ACCESS TO COMPREHENSIVE FOOT AND ANKLE CARE, INCLUDING ADVANCED SURGICAL OPTIONS AND MEDICATION MANAGEMENT. CONVERSELY, IN STATES WITH MORE RESTRICTIVE SCOPES, PATIENTS MIGHT FACE REFERRALS TO OTHER SPECIALISTS, POTENTIALLY DELAYING TREATMENT.

MOREOVER, WITH THE RISE OF CHRONIC CONDITIONS LIKE DIABETES AND PERIPHERAL ARTERY DISEASE, WHICH SIGNIFICANTLY AFFECT FOOT HEALTH, HAVING PODIATRISTS EQUIPPED TO PERFORM A WIDE RANGE OF FUNCTIONS CAN IMPROVE PREVENTATIVE CARE AND REDUCE COMPLICATIONS.

LOOKING AHEAD: TRENDS IN PODIATRY SCOPE OF PRACTICE

THE LANDSCAPE OF PODIATRY SCOPE OF PRACTICE BY STATE IS GRADUALLY EVOLVING. MANY STATES ARE REVIEWING AND UPDATING REGULATIONS TO EXPAND PODIATRISTS' ROLES, RECOGNIZING THEIR SPECIALIZED TRAINING AND THE GROWING DEMAND FOR FOOT AND ANKLE HEALTHCARE. TELEMEDICINE, ADVANCES IN SURGICAL TECHNIQUES, AND INTEGRATED CARE MODELS ARE ALSO INFLUENCING HOW PODIATRISTS PRACTICE.

PROFESSIONAL ORGANIZATIONS CONTINUE TO ADVOCATE FOR UNIFORMITY IN SCOPE TO FACILITATE MOBILITY AND STANDARDIZE CARE QUALITY. WHILE COMPLETE HARMONIZATION MAY TAKE TIME, THE TREND LEANS TOWARD GREATER AUTONOMY AND EXPANDED SERVICES FOR PODIATRISTS NATIONWIDE.

NAVIGATING THE COMPLEX MAZE OF PODIATRY SCOPE OF PRACTICE BY STATE IS AN ONGOING JOURNEY FOR PRACTITIONERS AND PATIENTS ALIKE. BEING INFORMED AND ADAPTABLE ENSURES THAT THE FOOT AND ANKLE CARE PROVIDED IS BOTH LEGALLY COMPLIANT AND CLINICALLY EFFECTIVE, NO MATTER WHERE YOU ARE IN THE UNITED STATES.

FREQUENTLY ASKED QUESTIONS

WHAT DOES THE PODIATRY SCOPE OF PRACTICE TYPICALLY INCLUDE ACROSS MOST STATES?

THE PODIATRY SCOPE OF PRACTICE GENERALLY INCLUDES DIAGNOSING AND TREATING CONDITIONS OF THE FOOT, ANKLE, AND RELATED STRUCTURES, PERFORMING SURGERIES, PRESCRIBING MEDICATIONS, AND PROVIDING PREVENTIVE CARE. HOWEVER, SPECIFIC PROCEDURES AND AUTHORITY CAN VARY BY STATE.

HOW DOES THE PODIATRY SCOPE OF PRACTICE VARY BETWEEN STATES?

SCOPE OF PRACTICE FOR PODIATRISTS VARIES BY STATE IN TERMS OF SURGICAL PRIVILEGES, PRESCRIPTION AUTHORITY, USE OF ANESTHESIA, AND DIAGNOSTIC TESTING CAPABILITIES. SOME STATES ALLOW EXTENSIVE SURGICAL PROCEDURES AND FULL PRESCRIPTION AUTHORITY, WHILE OTHERS HAVE MORE RESTRICTIVE REGULATIONS.

ARE PODIATRISTS ALLOWED TO PERFORM SURGERY IN ALL STATES?

NO, THE ABILITY FOR PODIATRISTS TO PERFORM SURGERY DEPENDS ON STATE REGULATIONS. MOST STATES PERMIT PODIATRISTS TO PERFORM FOOT AND ANKLE SURGERIES, BUT THE EXTENT OF SURGICAL PROCEDURES ALLOWED CAN DIFFER SIGNIFICANTLY.

CAN PODIATRISTS PRESCRIBE MEDICATIONS IN EVERY STATE?

IN MOST STATES, PODIATRISTS HAVE THE AUTHORITY TO PRESCRIBE MEDICATIONS RELATED TO THEIR PRACTICE, INCLUDING ANTIBIOTICS AND PAIN MANAGEMENT DRUGS. HOWEVER, THE SPECIFIC TYPES OF MEDICATIONS AND CONTROLLED SUBSTANCES THEY CAN PRESCRIBE VARY BY STATE LAW.

DO ALL STATES ALLOW PODIATRISTS TO USE ANESTHESIA?

NOT ALL STATES GRANT PODIATRISTS THE AUTHORITY TO ADMINISTER ANESTHESIA. SOME STATES RESTRICT PODIATRISTS TO LOCAL ANESTHESIA, WHILE OTHERS PERMIT THE USE OF REGIONAL OR GENERAL ANESTHESIA DURING PODIATRIC PROCEDURES.

HOW CAN PODIATRISTS FIND OUT THEIR SCOPE OF PRACTICE IN A SPECIFIC STATE?

PODIATRISTS CAN REVIEW THE STATE'S PODIATRY LICENSING BOARD REGULATIONS, STATE STATUTES, AND ADMINISTRATIVE CODES. PROFESSIONAL ORGANIZATIONS SUCH AS THE AMERICAN PODIATRIC MEDICAL ASSOCIATION (APMA) ALSO PROVIDE RESOURCES REGARDING STATE-SPECIFIC SCOPE OF PRACTICE.

HAS THE PODIATRY SCOPE OF PRACTICE BEEN EXPANDING IN RECENT YEARS?

YES, MANY STATES HAVE EXPANDED THE PODIATRY SCOPE OF PRACTICE TO ALLOW FOR GREATER SURGICAL PRIVILEGES, ENHANCED PRESCRIPTION AUTHORITY, AND BROADER DIAGNOSTIC CAPABILITIES. THIS EXPANSION AIMS TO IMPROVE PATIENT ACCESS TO COMPREHENSIVE FOOT AND ANKLE CARE.

UNDERSTANDING PODIATRY SCOPE OF PRACTICE

THE PODIATRY SCOPE OF PRACTICE REFERS TO THE RANGE OF CLINICAL ACTIVITIES AND MEDICAL SERVICES THAT LICENSED PODIATRISTS ARE AUTHORIZED TO PERFORM WITHIN THEIR JURISDICTION. THESE ACTIVITIES OFTEN INCLUDE DIAGNOSING FOOT AND ANKLE CONDITIONS, PERFORMING SURGICAL INTERVENTIONS, PRESCRIBING MEDICATIONS, AND PROVIDING REHABILITATIVE CARE. HOWEVER, THE EXTENT OF THESE FUNCTIONS CAN DIFFER SIGNIFICANTLY DEPENDING ON STATE LAWS, REGULATORY BOARDS, AND HISTORICAL PRECEDENTS.

THIS VARIABILITY STEMS FROM THE DECENTRALIZED NATURE OF HEALTHCARE REGULATION IN THE UNITED STATES, WHERE EACH STATE ESTABLISHES ITS OWN MEDICAL PRACTICE ACTS AND LICENSURE REQUIREMENTS. CONSEQUENTLY, PODIATRISTS PRACTICING IN CALIFORNIA MAY HAVE DIFFERENT LEGAL PRIVILEGES THAN THOSE IN TEXAS OR NEW YORK, AFFECTING THEIR OPERATIONAL CAPABILITIES AND PATIENT MANAGEMENT STRATEGIES.

VARIATIONS IN PODIATRY PRACTICE ACROSS STATES

LICENSING AND CERTIFICATION REQUIREMENTS

ONE OF THE FOUNDATIONAL ASPECTS INFLUENCING THE PODIATRY SCOPE OF PRACTICE IS THE LICENSING PROCESS. MOST STATES REQUIRE PODIATRISTS TO GRADUATE FROM AN ACCREDITED PODIATRIC MEDICAL SCHOOL AND COMPLETE A RESIDENCY PROGRAM. HOWEVER, SOME STATES IMPOSE ADDITIONAL CERTIFICATIONS OR MANDATE SPECIFIC CONTINUING EDUCATION FOCUSED ON SURGERY OR PHARMACOLOGY TO EXPAND PRACTICE RIGHTS.

FOR EXAMPLE, STATES LIKE FLORIDA AND NEW JERSEY REQUIRE PODIATRISTS TO OBTAIN A SEPARATE SURGICAL CERTIFICATE TO PERFORM ADVANCED FOOT AND ANKLE SURGERIES, WHILE OTHERS GRANT THIS AUTHORITY AUTOMATICALLY UPON LICENSURE. THESE DIFFERENCES INEVITABLY IMPACT THE COMPLEXITY OF CASES PODIATRISTS CAN MANAGE INDEPENDENTLY.

SURGICAL PRIVILEGES AND LIMITATIONS

SURGICAL PRIVILEGES ARE AMONG THE MOST SIGNIFICANT DIFFERENCES WHEN COMPARING THE PODIATRY SCOPE OF PRACTICE BY STATE. WHILE PODIATRISTS ARE GENERALLY TRAINED IN FOOT AND ANKLE SURGERIES, THE DEPTH AND BREADTH OF PERMITTED

SURGICAL PROCEDURES MAY VARY.

IN SOME STATES, SUCH AS ARIZONA AND NEVADA, PODIATRISTS CAN PERFORM A WIDE RANGE OF SURGERIES, INCLUDING BONE, TENDON, AND LIGAMENT PROCEDURES WITHOUT ADDITIONAL OVERSIGHT. CONVERSELY, STATES LIKE MASSACHUSETTS MAY RESTRICT CERTAIN INVASIVE SURGERIES TO ORTHOPEDIC SURGEONS OR REQUIRE HOSPITAL PRIVILEGES THAT ARE MORE CHALLENGING FOR PODIATRISTS TO OBTAIN.

THESE LIMITATIONS CAN AFFECT PATIENT ACCESS TO SPECIALIZED FOOT CARE, ESPECIALLY IN RURAL OR UNDERSERVED AREAS WHERE PODIATRISTS OFTEN SERVE AS PRIMARY FOOT HEALTH PROVIDERS.

PRESCRIPTIVE AUTHORITY

THE ABILITY TO PRESCRIBE MEDICATIONS IS ANOTHER CRITICAL COMPONENT OF THE PODIATRY SCOPE OF PRACTICE. MOST STATES AUTHORIZE PODIATRISTS TO PRESCRIBE A RANGE OF PHARMACEUTICALS, INCLUDING ANTIBIOTICS, ANTI-INFLAMMATORY DRUGS, AND PAIN MANAGEMENT MEDICATIONS. HOWEVER, THE EXTENT OF THIS AUTHORITY VARIES, PARTICULARLY REGARDING CONTROLLED SUBSTANCES.

FOR EXAMPLE, STATES SUCH AS CALIFORNIA AND OREGON ALLOW PODIATRISTS TO PRESCRIBE SCHEDULE II THROUGH V CONTROLLED SUBSTANCES, WHEREAS OTHERS MAY LIMIT THIS TO SCHEDULE III OR LOWER, IMPACTING THEIR CAPACITY TO MANAGE COMPLEX PAIN CONDITIONS EFFECTIVELY.

NEVERTHELESS, SOME STATES IMPOSE RESTRICTIONS OR REQUIRE COLLABORATION WITH OTHER MEDICAL SPECIALISTS FOR CERTAIN TESTS.

THIS DIVERGENCE INFLUENCES THE DIAGNOSTIC EFFICIENCY AND THE ABILITY OF PODIATRISTS TO PROVIDE COMPREHENSIVE CARE WITHOUT UNNECESSARY REFERRALS OR DELAYS.

CALIFORNIA

CALIFORNIA OFFERS ONE OF THE BROADEST SCOPES OF PRACTICE FOR PODIATRISTS. LICENSED PODIATRISTS CAN PERFORM EXTENSIVE SURGICAL PROCEDURES, PRESCRIBE A WIDE RANGE OF MEDICATIONS, AND ORDER DIAGNOSTIC TESTS INDEPENDENTLY. THE CALIFORNIA BUSINESS AND PROFESSIONS CODE SUPPORTS PODIATRIC MEDICAL PRACTICE WITH RELATIVELY LIBERAL REGULATIONS, MAKING IT AN ATTRACTIVE STATE FOR PODIATRISTS SEEKING AUTONOMY.

TEXAS

TEXAS HAS A MODERATELY EXPANSIVE SCOPE BUT WITH SOME NOTABLE RESTRICTIONS. WHILE PODIATRISTS CAN PERFORM MANY SURGICAL PROCEDURES AND PRESCRIBE MEDICATIONS, THERE ARE LIMITATIONS ON CONTROLLED SUBSTANCES AND CERTAIN INVASIVE SURGERIES. THE TEXAS MEDICAL BOARD OVERSEES PODIATRIC PRACTICE, ENSURING PRACTITIONERS MEET RIGOROUS STANDARDS BUT MAINTAINING SOME CONSERVATISM IN SCOPE EXTENSION.

NEW YORK

NEW YORK'S PODIATRY SCOPE IS COMPREHENSIVE BUT INCLUDES ADDITIONAL CERTIFICATION REQUIREMENTS FOR SOME SURGICAL INTERVENTIONS. THE STATE MANDATES RESIDENCY COMPLETION AND PASSING BOARD EXAMINATIONS BUT RESTRICTS SOME ADVANCED SURGERIES TO HOSPITALS OR COLLABORATIVE SETTINGS. PRESCRIPTION AUTHORITY IS ROBUST, THOUGH CONTROLLED SUBSTANCE PRESCRIBING IS MONITORED CLOSELY.

FACTORS INFLUENCING STATE-LEVEL DIFFERENCES

SEVERAL FACTORS CONTRIBUTE TO THE VARIABILITY IN PODIATRY SCOPE OF PRACTICE BY STATE:

- **HISTORICAL DEVELOPMENT:** STATES WITH A LONGER HISTORY OF PODIATRIC MEDICINE INTEGRATION TEND TO OFFER BROADER SCOPES DUE TO ESTABLISHED PRECEDENTS.
- **MEDICAL BOARD POLICIES:** STATE MEDICAL BOARDS REGULATE SCOPE CHANGES AND MAY IMPOSE CONSERVATIVE OR PROGRESSIVE GUIDELINES.
- **POLITICAL AND PROFESSIONAL LOBBYING:** INFLUENCE FROM MEDICAL ASSOCIATIONS, INCLUDING ORTHOPEDIC AND GENERAL MEDICAL GROUPS, CAN AFFECT SCOPE NEGOTIATIONS.
- **PUBLIC HEALTH NEEDS:** STATES FACING SHORTAGES IN FOOT CARE PROVIDERS MAY EXPAND PODIATRISTS' SCOPE TO ENHANCE ACCESS.

INTERSTATE PRACTICE AND TELEMEDICINE

WITH THE RISE OF TELEMEDICINE AND INTERSTATE LICENSING COMPACTS, UNDERSTANDING THE PODIATRY SCOPE OF PRACTICE BY STATE BECOMES EVEN MORE CRITICAL. TELEHEALTH SERVICES ALLOW PODIATRISTS TO CONSULT PATIENTS ACROSS STATE LINES, BUT THEY MUST COMPLY WITH THE SCOPE REGULATIONS OF BOTH THEIR LICENSING STATE AND THE PATIENT'S LOCATION. THIS COMPLEXITY UNDERSCORES THE IMPORTANCE OF HARMONIZING REGULATIONS TO FACILITATE SEAMLESS CARE DELIVERY.

IMPLICATIONS FOR PATIENTS AND PROVIDERS

THE DIFFERENCES IN PODIATRY SCOPE OF PRACTICE BY STATE HAVE PRACTICAL IMPLICATIONS. PATIENTS IN STATES WITH MORE RESTRICTIVE SCOPES MAY EXPERIENCE LIMITED ACCESS TO ADVANCED SURGICAL CARE OR REQUIRE MULTIPLE REFERRALS, POTENTIALLY DELAYING TREATMENT. CONVERSELY, STATES WITH BROADER SCOPES ENABLE PODIATRISTS TO PROVIDE COMPREHENSIVE, TIMELY CARE THAT CAN IMPROVE OUTCOMES AND REDUCE HEALTHCARE COSTS.

FOR PODIATRISTS, UNDERSTANDING STATE-SPECIFIC REGULATIONS IS CRUCIAL FOR COMPLIANCE, PROFESSIONAL DEVELOPMENT, AND OPTIMIZING PATIENT CARE STRATEGIES. IT ALSO INFLUENCES DECISIONS ON WHERE TO PRACTICE AND HOW TO STRUCTURE THEIR SERVICES.
